

**ADDENDUM NO 1. TO STANDARD STUDENT DATA PRIVACY AGREEMENT BETWEEN  
MCLEAN COUNTY UNIT 5 SCHOOL DISTRICT AND SCHOLASTIC INC. EFFECTIVE MAY 5, 2021**

This Addendum No. 1 ("Addendum") dated September 19, 2023 is hereby incorporated into an existing Agreement between Mclean County Unit 5 School District (the "LEA") and Scholastic Inc. ("Provider" or "Scholastic") effective as of May 5, 2021 (the "DPA" or "Agreement"). Capitalized terms used without definition shall have the respective definition set forth in the Contract.

NOW THEREFORE, the parties hereby agree as follows:

1. Paragraph 4 of the DPA is amended as follows:  
"The Term of the DPA and the Exhibit E is extended for an additional three (3) year period, and shall expire May 5, 2027."
2. The Exhibit B is deleted in its entirety and replaced by the Exhibit B attached hereto.
3. The Exhibit E is deleted in its entirety and replaced by the Exhibit E attached hereto.

This Addendum shall be effective immediately. Except as expressly amended hereby, all other terms and conditions of the DPA shall remain in effect.
