Our principles:

We are absolutely committed to protecting your privacy. Our policy can be summarized in one sentence: We will not share your information with others without your prior consent. To uphold these principles, **eSchool News Online** has established the following four principles:

1. We will continue to invest in high-quality security and do our utmost to protect user privacy through the appropriate use of the latest security technology.

- 2. We will respect your email privacy. You will not receive unsolicited mail from **eSchool News Online** and/or from third parties screened by **eSchool News Online** unless you have agreed to this. We will, however, mail you occasionally with information about your registration and/or your subscription account.
- 3. We will not pass on any individual user details (including your email address) unless we have your prior consent.
- 4. Otherwise, we will only share anonymous aggregate statistics about our users, sales, and traffic patterns with our advertisers.

Should we elect to change our privacy policy we will post the changes here. Where the changes are significant, we may also choose to eMail all our registered users with new details.

Optional Services:

For certain optional services, **eSchool News Online** requires that you supply a unique subscriber ID, eMail address, and demographic information, such as title and school district.

- Registration/Subscriptions: For customers' convenience, eSchool News
 Online makes it possible to subscribe via credit card to the eSchool News
 Online family of publications and register for various conferences sponsored
 by eSchool News.
- **Surveys:** On occasion, **eSchool News Online** also collects additional personal information in connection with optional contests, surveys, or special offers.
- IP Addresses:eSchool News Online logs IP addresses, or the location of your computer on the internet, for systems administration and troubleshooting purposes.

What does eSchool News do with the information it gathers/tracks?

Statistical Analysis and Banner Advertising:eSchool News Online may perform statistical analyses of user behavior in order to measure interest in the various areas of our site (for product development purposes) and to inform advertisers as to how many consumers have seen or "clicked" their advertising banners. All information is used in aggregate form and no personal information is tied to individual users.

eMail: Using the eMail addresses provided at registration, eSchool News

Online periodically sends promotional eMail to its subscribers about services offered by eSchool News Online and its advertisers. eSchool News Online may contact you regarding account status, changes to the subscriber agreement, and to confirm registration. Data Security: To prevent unauthorized access, maintain data accuracy, and ensure the appropriate use of information, **eSchool News Online** has put in place appropriate physical, electronic, and managerial procedures to protect the information it collects online. With whom does eSchool News Online share the information it gathers and tracks?

eSchool News Online uses the information it gathers to promote special pricing and discount offers for our newspaper, newsletters, directories, and conferences. The information gathered may also be shared with advertisers and other partners. **eSchool News Online** will provide registered users with all personal information collected at the time of registration upon request. This information will be sent only to the eMail address on file for the unique subscriber ID associated with it.

During the registration process, new users may select to register for various eMail publications. If you select this option, **eSchool News Online** will use the information collected on the registration form to send targeted eMails to you on behalf of advertisers. **eSchool News Online** subscribers may opt-out of this service at any time. Blogs and RSS feeds:

eSchool News Online offers optional resources for communications. Any information you disclose when posting a message in these tools becomes public. Moreover, subscribers who post a message in our communications make their eMail address available to others through a feature of our communications software, which could result

Children's Guidelines:
