


**EXHIBIT "E"**  
**GENERAL OFFER OF PRIVACY TERMS**

**1. Offer of Terms**

Provider agrees that it will follow the same protocols and practices expressly set forth in the DPA and any applicable amendments thereto between Provider and the Originating LEA (Maine School Administrative District 52) (dated March 22, 2022) with any other school district ("Subscribing LEA") who accepts this general offer of privacy terms (the "General Offer") through its signature below. For purposes of following the DPA, as amended, references to LEA shall mean and include the Subscribing LEA. This General Offer shall extend only to privacy protections and Provider's signature shall not necessarily bind Provider to other terms, such as price, term, or schedule of services, or to any other provision not addressed in the DPA. The Provider may withdraw the General Offer in the event of: (1) a material change in the applicable privacy statutes; (2) a material change in the services and products subject listed in the Originating Service Agreement; or (3) three (3) years after the date of the Provider's signature on the original Exhibit "E". Provider shall notify the LEA and any Subscribing LEAs in the event of any withdrawal.
