

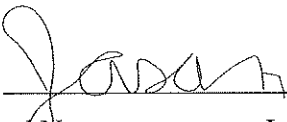
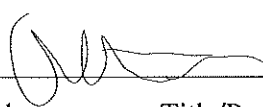
## EXHIBIT "E"
