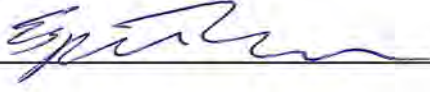


EXHIBIT "E"
GENERAL OFFER OF PRIVACY TERMS

1. Offer of Terms
