1. Offer of Terms

The Provider agrees that the information on the next page will be replaced throughout the Agreement with the information specific to the Subscribing LEA filled on the next page for the Subscribing LEA. This General Offer shall extend only to privacy protections and Provider's signature shall not necessarily bind Provider to other terms, such as price, term, or schedule of services, or to any other provision not addressed in this DPA. The Provider and the Subscribing LEA may also agree to change the data provide by LEA to the Provider to suit the unique needs of the Subscribing LEA. The Provider may withdraw the General Offer in the event of: (1) a material change in the applicable privacy statutes; (2) a material change in the services and products subject listed in the Originating Service Agreement; or three (3) years after the date of Provider's signature to this Form. Provider shall notify the LEA in the event of any withdrawal so that this information may be transmitted to the Subscribing LEAs.

EXHIBIT "F" DATA SECURITY REQUIREMENTS

The Vermont Student Data Privacy Agreement ("DPA") between Lamoille South Supervisory Union ("LEA") and Mystery Science, Inc. ("Provider") is amended as follows, as of the last date set forth below. All other terms of the DPA remain unchanged.

Article I, Paragraph 1, 2nd sentence shall be modified as follows: "In performing these Services, Provider and its Subprocessors shall be considered a School Official with a legitimate educational interest, and performing services otherwise provided by the LEA."

Article IV, Paragraph 2, after the first sentence, insert the following: "Provider may share teacher and staff email addresses and contact information with third party service providers, but only to the extent necessary for the service providers to perform services on behalf of Provider under the Service Agreement."

Article IV, Paragraph 5, 1st sentence shall be modified as follows: "Upon written request by LEA and in accordance with the applicable terms of subsection a or b, below, Provider shall dispose or delete all Student Data obtained under the Service Agreement when it is no longer needed for the purpose for which it was obtained."

Article V, Paragraph 1(a), 3rd sentence shall be modified as follows: "Employees with access to Student Data shall have signed a confidentiality agreement with Provider whereby employees recognize the obligation to protect confidential information of third parties."


Article VII, Paragraph 2, 2nd sentence shall be modified as follows: "LEA shall have right to terminate the DPA and Service Agreement in the event of a material breach of the terms of this DPA that remains uncured after thirty (30) days of notice of breach."

Exhibit E, Paragraph 1, 1st sentence shall be modified as follows: "Provider offers the same privacy protections found in this DPA, as amended, between it and Lamoille South Supervisory Union and which is dated June 4, 2019 to any other LEA ("Subscribing LEA") who accepts this General Offer through its signature below."

Exhibit E, Paragraph 2, 2nd sentence shall be modified as follows: "The Subscribing LEA and the Provider shall therefore be bound by the same terms of this DPA, as amended."
