1. Offer of Terms

The Provider may withdraw the General Offer in the event of: (1) a material change in the applicable privacy statutes; (2) a material change in the services and products subject listed in the Originating Service Agreement; three (3) years after the date of Provider's signature to this Form; or (4) Exhibit E is signed by an LEA who has not contracted School Account Services with Provider, or has ceased to contract with Provider for School Account Services. Provider shall notify the LEA in the event of any withdrawal so that this information may be transmitted to the Subscribing LEAs.
