AMENDMENT NO. 1 TO MASSACHUSETTS STUDENT DATA PRIVACY AGREEMENT

This AMENDMENT NO. 1 TO MASSACHUSETTS STUDENT DATA PRIVACY AGREEMENT (this "Amendment") is effective as of the date of the last signature below (the "Effective Date") and is entered into by and between South Shore Educational Collaborative, located at 75 Abington Street, Hingham, MA 02043 (the "LEA") and iCivics, Inc., located at 1035 Cambridge Street, Suite 21B, Cambridge, MA 02141 (the "Provider"). Any capitalized term that is used but not otherwise defined in this Amendment shall have the meaning given to that term in that certain Massachusetts Student Data Privacy Agreement between the Parties dated as of June 12, 2020 (the "DPA").

RECITALS

WHEREAS, the Parties entered into the DPA, pursuant to which the Parties wished to ensure that the Services provided conformed to the requirements of applicable privacy laws and to establish certain duties; and

WHEREAS, the Parties desire to amend and restate the DPA as set forth herein.

NOW, THEREFORE, the Parties hereby agree as follows:

1. <u>Term</u>. Article VI, Section 1 of the DPA is hereby amended and restated in its entirety and replaced with the following:

"This DPA shall stay in effect for as long as the Provider has access to Student Data."

- **2.** <u>Subscribing LEAs</u>. Any Subscribing LEA that signed the General Offer of the DPA may, by signing the attached Amendment Terms (attached hereto as <u>Exhibit "A"</u>), be bound by the terms of this Amendment.
- **3.** <u>Counterparts; Effectiveness</u>. This Amendment may be signed in any number of counterparts, each of which shall be an original, with the same effect as if the signatures thereto and hereto were upon the same instrument.
- **4. <u>DPA</u>**. Except as amended by this Amendment, the DPA shall remain in full force and effect and all terms and conditions of the DPA shall apply to this Amendment *mutatis mutandis*.
