- 2. Provider, by signing the attached Exhibit E Amended Form of General Offer of Privacy Terms, will be bound by the terms of this amendment and the DPA with any Subscriber LEA that duly countersigns the Exhibit E Amended Form of General Offer of Privacy Terms. The Education Cooperative will follow up with Subscriber LEAs to ensure that they execute the Exhibit E Amended Form of General Offer of Privacy Terms.

This Addendum shall be effective immediately. Except as expressly amended hereby, all other terms and conditions of the DPA shall remain in effect.
