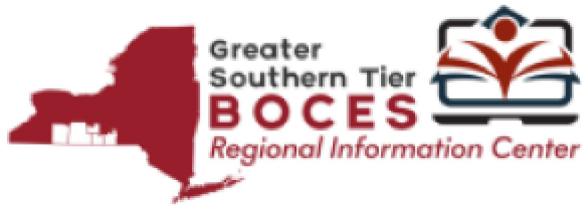
I have spoken with the rest of the team and was wondering if it would be possible to get a vendor statement that says that you collect no PII?
