Accountability

SOAR® Learning, Inc., Studyskills.com and soarlearning.com, is responsible for personal identifiable information under its control and for designating individual(s) accountable for compliance with the following principles.

Identifying purposes

The purposes for collecting personal identifiable information shall be identified at or before the time the information is collected.

Consent

The knowledge and consent of the individual are required for the collection, use, or disclosure of personal information, except where inappropriate.

Limiting collection

The collection of personal identifiable information shall be limited to that which is necessary for the purposes identified by SOAR® Learning, Inc., Studyskills.com and soarlearning.com,. Information shall be collected by fair and lawful means. SOAR Learning, Inc. does not collect data concerning: political affiliation or beliefs; mental or psychological problems; sex behavior or attitudes; illegal, anti-social, self-incriminating or demeaning behavior; critical appraisals of other individuals; legally recognized privileged or analogous relationships such as lawyers, physicians, and ministers; religious practices, affiliations or beliefs; or income.

Limiting use, disclosure, and retention of personal information shall not be used or disclosed for purposes other than those for which it was collected, except with the consent of the individual or as required by law. Personal information shall be retained only as long as necessary for the fulfillment of those purposes.

Accuracy

Challenging compliance

How we share or transfer data

We do not rent or sell Personal Identifiable Information, Persistent Identifiers, or any other information that we collect from Users, or exploit it for financial gain in any other way. SOAR® Learning, Inc., Studyskills.com and soarlearning.com, will never share or grant rights to personal identifiable information with other third-party organizations to use without your consent, except as part of a specific program or feature for which you will have the explicit ability and choice to opt-in.

We may share student achievement data with your school or school district.

If your use of the SOAR® Learning, Inc., Studyskills.com and soarlearning.com, is in the context of a partnership with your school or school district, we may allow the school or school district to access the same student progress report that is also shared with your teacher(s).

We may share student achievement data with a User's parent/guardian upon request.

Under FERPA, we guarantee a parent's right to access and review their child's (user's) data. Parent's , upon request, have the right to review data collection surveys before administered to student.

Public reporting on student use and performance

SOAR® Learning, Inc., Studyskills.com and soarlearning.com may publish anonymized information about student performance in tutorials and Websites, however, we will never publicly disclose your Personal Information in these reports. Data about student performance will remain anonymized, but aggregated. Anonymized data over large populations of students may be reported by demographic criteria such as grade level, general location, type of school, and grade-point average.

We may share anonymous or aggregate data to improve our services and learn more about our Users.

In certain occasions, SOAR® Learning, Inc., Studyskills.com and soarlearning.com, may work with third parties (such as universities and education research organizations) to improve our services or offerings. We will share data when required by law
