OF THE IL-NDPA v.1.0a


LEA will execute "Exhibit E" to the Standard Student Data Privacy Agreement IL-NDPA v.1.0a (Agreement) entered into between McLean County Unit 5 School District and Provider. In that Agreement, Provider has provided modifications to the standard terms through executing "Exhibit H." LEA and Provider enter into this First Amendment which modifies and overrides changes to Exhibit H to the Agreement to the sections set forth below:

Article IV, Section 2 – Provider agrees to delete its modification to this section and retain the standard language of the IL-NDPA v.1.0a.

Article IV, Section 4 – Provider and LEA agree to the following revision of this section:

No Disclosure. Provider acknowledges and agrees that it shall not make any re-disclosure of any Student Data or any portion thereof, including without limitation, user content or other non-public information and/or personally identifiable information contained in the Student Data other than as directed or permitted by the LEA or this DPA. This prohibition against disclosure shall not apply to ~~aggregate summaries of De-Identified information~~ Data, Student Data disclosed pursuant to a lawfully issued subpoena or other legal process, ~~or to~~ subprocessors performing services on behalf of the Provider pursuant to this DPA, Student Data of an authorized user disclosed to that user, or to the extent permitted by State or federal law, to law enforcement officials to protect the safety of users or others or the security or integrity of the operator's service. Provider will not Sell Student Data to any third party.
