

Amendment No. 1 to New Hampshire Student Data Privacy Agreement

This Amendment No. 1 to New Hampshire Student Data Privacy Agreement (“Amendment”) is effective as of the date of the last signature hereto (the “Effective Date”), by and between Great Minds PBC (“GM”), and Oyster River Cooperative School District (“LEA”). The foregoing are collectively referred to as the “Parties.”

**WHEREAS**, GM and LEA have previously entered into that certain New Hampshire Student Data Privacy Agreement dated as of October 29, 2020 (the “DPA”); and

**WHEREAS**, the Parties desire to amend the DPA;

NOW, THEREFORE, for good and valuable consideration, the exchange, receipt and sufficiency of which are acknowledged, the parties hereby agree as follows:

1. **The following descriptions of services shall be added to Exhibit "A":**

**Eureka Math<sup>2</sup>™ Premium Assessments:** Includes Eureka Math Squared Equip and Eureka Math Squared Benchmark Assessments. Eureka Math Squared Equip includes a set pre-module assessments for grades 1-9 to identify and address student knowledge gaps; plus a curated set of supporting activities guidance for teachers to keep instruction on schedule. Three Benchmark Assessments for each grade 1-9 identify students’ progress on the major learning of the curriculum throughout the year.


**Eureka Math<sup>2</sup>™ Digital Platform:** Teacher-facing and student-facing digital platforms that allow teachers to have full access to the K-9 curriculum, including digital-only resources such as context videos, digital interactives, and digital assessments with available auto-scoring and reporting.

Except as set forth in this Amendment, all other terms and conditions of the Agreement shall continue in full force and effect.
