

**Hudl  
District Addendum**

This Hudl District Addendum is an addendum to the Hudl Organization Terms of Service available at <https://www.hudl.com/eula> ("Org Terms" and, together with this District Addendum, the "Agreement") is by and between Agile Sports Technologies, Inc. ("Hudl") and the district or board identified below ("Signatory"). This Agreement shall automatically apply to the schools in Signatory's district who are identified herein ("Member Schools") and to their use of Hudl's software and services. Member Schools shall each be deemed an "Organization" for purposes of the Org Terms. Subscriber represents and warrants that Subscriber has the authority to agree to the terms of the Agreement on behalf of the Member Schools. If this Order is returned to Hudl after the estimated start date identified below, Hudl may adjust the start and end dates to reflect the actual dates of service without changing the total days of service or price. Payments are due annually. First Invoice will be sent when the executed order form is returned to Hudl by the customer. Payment terms are Net 30.

For purposes of this Agreement only, the Org. Terms are modified as follows:

- A. Section 8 (Term and Termination) of the Org. Terms is hereby deleted in its entirety and replaced with the following:

These Organization Terms shall commence upon the activation of an Organization's Subscription and will continue for the initial period specified in the Organization's invoice or the order, agreement, or quote provided by Hudl to Organization which describes the Services Organization is receiving, whichever is applicable (the "Initial Term"). Following the Initial Term, the parties may choose to renew Organization's Subscriptions upon mutual written agreement (each a "Renewal Term" and together with the Initial Term, the "Term"). The Organization Terms shall apply to any renewal. Organization may cancel its Subscriptions for one or more Teams at any time prior to the then-current Initial Term or Renewal Term, as applicable. Hudl may terminate these Organization Terms if Organization materially breaches these Organization Terms and fails to cure such breach within five (5) business days after written notice thereof. Upon termination, Organization shall have no further rights hereunder and shall promptly remove any Installed Software from all computers.

- B. The following language is added to Section 5.1 (Platform License Grant) of the Org. Terms:

These Organization Terms shall not be interpreted as preventing Organization from streaming, posting, sharing or otherwise distributing Organization's Video or other content provided to Hudl by Organization via other services or platforms.

The remainder of Section 5.1 shall remain unchanged.


- C. Section 12.2 of the Org. Terms is hereby deleted in its entirety and replaced with the following:

These Organization Terms are governed by the laws of the State of Illinois, except for its conflict of laws provisions. Venue for all disputes arising under these Organization Terms shall lie exclusively in the District Courts of the State of Illinois or the Federal District Court of the District of Illinois (as permitted by law) and each party agrees not to contest the personal jurisdiction of these courts.


All other Org. Term provisions shall remain unchanged and are hereby ratified and confirmed by the parties.

Each party has agreed to the terms of this Agreement on the date set forth below its signature.
