This Utah Student Data Privacy Agreement ("DPA") is entered into by and between the Weber School District (hereinafter referred to as "LEA") and Scholastic Inc. (hereinafter referred to as "Contractor") on November 1, 2019 The Parties agree to the terms as stated herein.

### RECITALS

WHEREAS, the Contractor has agreed to provide the Local Education Agency ("LEA") with certain digital educational services ("Services") pursuant to a Contractor's End User License Agreement ("EULA"); and

WHEREAS, in order to provide the Services described in the EULA, the Contractor may receive or create, and the LEA may provide documents or data that are covered by several federal statutes, among them, the Family Educational Rights and Privacy Act ("FERPA") at 20 U.S.C. 1232g (34 CFR Part 99), Children's Online Privacy Protection Act ("COPPA"), 15 U.S.C. 6501-6506; Protection of Pupil Rights Amendment ("PPRA") 20 U.S.C. 1232h; and

WHEREAS, the documents and data transferred from LEAs and created by the Contractor's Services are also subject to Utah state student privacy laws, including the Utah Student Data Protection Act UCA Section 53E-9; and

WHEREAS, for the purposes of this DPA, Contractor is a school official with legitimate educational interests in accessing Education Records pursuant to the EULA for the limited purposes of this DPA; and

WHEREAS, the Parties wish to enter into this DPA to ensure that the EULA conforms to the requirements of the privacy laws referred to above and to establish implementing procedures and duties; and

WHEREAS, the Contractor may, by signing the "General Offer of Privacy Terms" (Exhibit "E"), agree to allow other LEAs in Utah the opportunity to accept and enjoy the benefits of this DPA for the Services described herein, without the need to negotiate terms in a separate DPA.

NOW THEREFORE, for good and valuable consideration, the parties agree as follows:

## ARTICLE I: PURPOSE AND SCOPE

1. Purpose of DPA. The purpose of this DPA is to describe the duties and responsibilities to protect student data transmitted to Contractor from LEA pursuant to the EULA, including compliance with all applicable statutes, including the FERPA, COPPA, PPRA and other applicable Utah State laws, all as may be amended from time to time. In performing these services, the Contractor shall be considered a School Official with a legitimate educational interest, and performing services otherwise provided by the LEA. With respect to the use and maintenance of Student Data, Contractor shall be under the direct control and supervision of the LEA.

- 2. <u>Nature of Services Provided</u>. The Contractor has agreed to provide digital educational products and services outlined in <u>Exhibit "A"</u>.
- 3. Student Data to Be Provided. The Parties shall indicate the categories of student data to be provided in the Schedule of Data, attached as Exhibit "B".
- 4. <u>DPA Definitions</u>. The definition of terms used in this DPA is found in <u>Exhibit "C"</u>. In the event of a conflict, definitions used in this DPA shall prevail over term used in the EULA.

## ARTICLE II: DATA OWNERSHIP AND AUTHORIZED ACCESS

- 1. Student Data Property of LEA. All Student Data transmitted to the Contractor pursuant to the EULA is and will continue to be the property of the student.
- 2. Parent Access. The LEA shall establish reasonable procedures by which a parent, legal guardian, or eligible student may request the opportunity to inspect and review Student Data in the student's records, and seek to amend Student Data that are inaccurate, misleading or in violation of the student's right of privacy. Contractor shall respond in a timely manner (and no later than 45 days from the date of the request) to the LEA's request for Student Data in a student's records held by the Contractor to view or correct as necessary. In the event that a parent of a student or other individual contacts the Contractor to review any of the Student Data accessed pursuant to the Services, the Contractor shall refer the parent or individual to the LEA, who will follow the necessary and proper procedures regarding the requested information.
- 3. Third Party Request. Should a Third Party, including law enforcement and government entities, request data held by the Contractor pursuant to the Services Agreement, the Contractor shall redirect the Third Party to request the data directly from the LEA. Contractor shall notify the LEA in advance of a compelled disclosure to a Third Party unless legally prohibited. Contractor shall share Student Data with law enforcement if required by law or court order.
- 4. <u>Sub-processors</u>. Contractor shall enter into written agreements with all Sub-processors performing functions pursuant to the EULA, whereby the Sub-processors agree to protect Student Data in a manner consistent with the terms of this DPA. On request, Contractor shall provide the LEA with a description of the sub-processors or types of sub-processors who have access to the LEA's student data and shall update the list as new sub-processors are added. Contractor's non-habitual inadvertent failure to so notify LEA of such additions shall not be deemed a material breach of this Agreement

## ARTICLE III: DUTIES OF CONTRACTOR

1. Privacy Compliance. The Contractor shall comply with all applicable state and federal

laws and regulations pertaining to data privacy and security, including FERPA, COPPA, PPRA and all other Utah privacy statutes as they relate to the collection, use, storage, or sharing of student data.

- 2. <u>Authorized Use</u>. The data shared pursuant to the EULA, including persistent unique identifiers, shall be used for no purpose other than the Services stated in the EULA and/or otherwise authorized under the statutes referenced in the prior subsection such as without limitation user authentication and support for internal operations. Contractor also acknowledges and agrees that it shall not make any re-disclosure of any Student Data except as required by law subject to the terms and conditions hereof.
- 3. <u>Employee Obligation</u>. Contractor shall ensure all employees and sub-processors who have access to Student Data comply with all applicable provisions of this DPA with respect to the data shared under the EULA.
- 4. <u>Use of De-identified information</u>. Aggregate or De-identified information may be used by the Contractor for the purposes of development, research, and improvement of educational sites, services, or applications, as any other member of the public or party would be able to use de-identified data pursuant to 34 CFR 99.31(b). Contractor agrees not to attempt to re-identify de-identified Student Data.
- 5. <u>Disposition of Data</u>. Upon written request Contractor shall dispose or delete all Student Data obtained under the EULA when it is no longer needed for the purpose for which it was obtained. The duty to dispose of Student Data shall not extend to data that has been de-identified. The LEA may employ a "Request for Return or Deletion of Student Data" form, a copy of which is attached hereto as <u>Exhibit "D"</u>. Upon receipt of a request from the LEA, the Contractor will immediately provide the LEA with any specified portion of the Student Data within 30 calendar days of receipt of said request.
- 6. Additional Acceptable Uses of Student Data. Contractor is prohibited from using Student Data for any secondary use not described in this agreement except:
  - a. for adaptive learning or customized student learning purposes;
  - to market an educational application or product to a parent or legal guardian of a student if Contractor did not use Data, shared by or collected per this Contract, to market the educational application or product;
  - c. to use a recommendation engine to recommend to a student
    - content that relates to learning or employment, within the third-party contractor's internal application, if the recommendation is not motivated by payment or other consideration from another party; or
    - services that relate to learning or employment, within the third-party contractor's internal application, if the recommendation is not motivated by payment or other consideration from another party;
  - d. to respond to a student request for information or feedback, if the content of the response is not motivated by payment or other consideration from another party.;
     and

e. to use Data to analyze, monitor, allow or improve operability and functionality of the third-party contractor's internal application.

### ARTICLE IV: DATA PROVISIONS

- 1. Data Security. The Contractor agrees to abide by and maintain adequate data security measures, consistent with standards and best practices within the educational technology industry, and to protect Student Data from unauthorized disclosure or acquisition by an unauthorized person. These measures shall include, but are not limited to:
  - a Passwords and Employee Access. Contractor shall secure usernames, passwords, and any other means of gaining access to the Services or to Student Data. Contractor shall only provide access to Student Data to employees or contractors that are performing the Services.
  - b. Security Protocols. Both parties agree to maintain security protocols that meet industry standards in the transfer or transmission of any data, including ensuring that data may only be viewed or accessed by parties legally allowed to do so. Contractor shall maintain all data obtained or generated pursuant to the EULA in a secure digital environment and not copy, reproduce, or transmit data obtained pursuant to the EULA, except as necessary to fulfill the purpose of data requests by LEA.
  - c Security Technology. Contractor shall employ internet industry standard measures to protect data from unauthorized access while the data is in transit or at rest. The service security measures shall include server authentication and data encryption. Contractor shall host data pursuant to the EULA in an environment using a firewall that is updated according to industry standards.
  - d. Audit Rights. Upon reasonable notice, and at the request of the LEA no more than once per a twelve month period and subject to Contractor's reasonable security and non-disclosure requirements, the LEA or the LEA's qualified designee may audit Contractor to verify compliance with this DPA, as required by the Utah Student Data Protection Act.
- 2 <u>Data Breach</u>. In the event that Contractor discovers that Student Data has been accessed or obtained by an unauthorized individual, Contractor shall provide notification to LEA within a reasonable amount of time of the incident, not to exceed ten (10) business days to LEA's designated representative noted in Article VI paragraph 5 (a).

Except as otherwise required by law or agreed to in writing between the parties and excluding student data or any other data that belongs to the LEA, all information provided by Contractor to the LEA pursuant to this paragraph or obtained by LEA or its designee pursuant an audit shall be treated as Contractor's confidential information. The LEA agrees that it will disclose such information only to such parties that the LEA determines are necessary to assist it in its review and require such parties to enter into non-disclosure agreements or otherwise agree in writing to maintain its confidentiality. To the extent

permitted by law, the LEA will withhold such information from public disclosure.

# ARTICLE V- GENERAL OFFER OF PRIVACY TERMS

Contractor may, by signing the attached Form of General Offer of Privacy Terms in <a href="Exhibit"><u>Exhibit</u></a> "E", be bound by the terms of this DPA to any other LEA who signs the acceptance on in said Exhibit.

## ARTICLE VI: MISCELLANEOUS

- 1. <u>Term.</u> The Contractor shall be bound by this DPA for the duration of the EULA or so long as the Contractor maintains any Student Data.
- 2. <u>Termination</u>. In the event that either party seeks to terminate this DPA, they may do so by mutual written consent so long as the EULA has lapsed or has been terminated. LEA shall have the right to terminate the DPA and EULA in the event of a material breach of the terms of this DPA.
- 3. Effect of Termination Survival. If the EULA is terminated, the Contractor shall destroy all of LEA's data pursuant to Article III, section 5 above. Notwithstanding the foregoing, Contractor's deletion obligation shall not extend to LEA data used in connection with other Contractor products and services, such as by way of example only, a general teacher account on Contractor's website.
- 4. **Priority of Agreements**. This DPA shall govern the treatment of student data in order to comply with privacy protections, including those found in FERPA and all applicable privacy statutes identified in this DPA. In the event there is conflict between the DPA and the EULA, the DPA shall apply and take precedence. Except as described in this paragraph herein, all other provisions of the EULA shall remain in effect.
- 5. <u>Notice</u>. All notices or other communication required or permitted to be given hereunder must be in writing and given by personal delivery, or e-mail transmission (if contact information is provided for the specific mode of delivery), or first-class mail, postage prepaid, sent to the designated representatives below:

b. Notification of Acceptance of General Offer of Terms. Upon execution of Exhibit "E", General Offer of Terms, Subscribing LEA shall provide notice of such acceptance in writing and given by personal delivery, or e-mail transmission (if contact information is provided for the specific mode of delivery), or first-class mail, postage prepaid, to the designated representative below.

- 6. Entire Agreement. This DPA and the EULA constitutes the entire agreement of the parties relating to the subject matter hereof and supersedes all prior communications, representations, or agreements, oral or written, by the parties relating thereto. This DPA may be amended and the observance of any provision of this DPA may be waived (either generally or in any particular instance and either retroactively or prospectively) only with the signed written consent of both parties.
- 7. Severability. Any provision of this DPA that is prohibited or unenforceable in any jurisdiction shall, as to such jurisdiction, be ineffective to the extent of such prohibition or unenforceability without invalidating the remaining provisions of this DPA, and any such prohibition or unenforceability in any jurisdiction shall not invalidate or render unenforceable such provision in any other jurisdiction. Notwithstanding the foregoing, if

such provision could be more narrowly drawn so as not to be prohibited or unenforceable in such jurisdiction while, at the same time, maintaining the intent of the parties, it shall, as to such jurisdiction, be so narrowly drawn without invalidating the remaining provisions of this DPA or affecting the validity or enforceability of such provision in any other jurisdiction.

- 8. Governing Law: Venue and Jurisdiction. THIS DPA WILL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF UTAH, WITHOUT REGARD TO CONFLICTS OF LAW PRINCIPLES. EACH PARTY CONSENTS AND SUBMITS TO THE SOLE AND EXCLUSIVE JURISDICTION TO THE STATE AND FEDERAL COURTS OF UTAH FOR ANY DISPUTE ARISING OUT OF OR RELATING TO THIS EULA OR THE TRANSACTIONS CONTEMPLATED HEREBY.
- 9. <u>Authority</u>. Contractor represents that it is authorized to agree and enter into the terms of this DPA, including confidentiality and destruction of Student Data and any portion thereof contained therein, and that it shall be responsible for the compliance with the Terms hereof of all related or associated institutions, individuals, employees or contractors who may have access to the Student Data and/or any portion thereof, or may own, lease or control equipment or facilities of any kind where the Student Data and portion thereof stored, maintained or used in any way. Contractor agrees that any purchaser of the Contractor shall also be bound to this DPA.
- 10. Waiver. No delay or omission of the LEA to exercise any right hereunder shall be construed as a waiver of any such right and the LEA reserves the right to exercise any such right from time to time, as often as may be deemed expedient. LEA hereby waives and releases any and all claims against the Utah State Board of Education and/or its members, departments, office, and staff (collectively, "USBE"), for USBE's efforts and conduct related to the negotiations and/or formation of this DPA. The parties agree that USBE is not an agent nor a representative of LEA in the formation or execution of this DPA, and that LEA negotiated with Contractor at arm's length in the creation of this DPA. USBE is thus not responsible or liable to either party under this DPA, and owes no duty to either party under this DPA.

10. <u>Successors Bound</u>. This DPA is and shall be binding upon the respective successors in interest to Contractor in the event of a merger, acquisition, consolidation or other business reorganization or sale of all or substantially all of the assets of such business.

#### DESCRIPTION OF SERVICES

Kim Irvine, ELA Curriculum Leader, with Weber SD will utilize Scholastic Literacy Pro as a pilot program for February 10, 2020 - May 8, 2020.

Scholastic Literacy Pro, for grades K-6, is a complete, blended reading resource that promotes independent reading for students, both in and out of school. The comprehensive and revolutionary program encourages students to take ownership of their reading development by selecting their own text based on interests and grade level and holding them accountable to reach the reading goals they set for themselves. Students have access to 2,300 fiction and nonfiction eBooks, including Spanish, as well as connections to thousands of print titles. The innovative platform of Literacy Pro fits Guided Reading and Lexile@ classrooms and offers students many engaging texts in order to student motivate and cultivate independent, lifelong readers.

## **Technology Product Description: Literacy Pro Data Elements**

School Service Provider: Scholastic Inc.

### Data collected:

- · Student first and last initial or last name
- Student ID (if provided)
- · Student user name and password
- · Reading goals (may take form of books added by student to the student's bookshelf)
- Books read (which may be recorded automatically or entered by a student manually) including reading level of each book.
- Minutes read and minutes in the program overall. "Minutes read" includes both e-book time
  (which is captured automatically) and time entered by a student manually. Minutes in the
  program includes any time spent in the application (including browsing books, reading books,
  taking "Think Mores" and reviewing books).
- Book ratings and reviews. Only student who posted the review and their teacher can read the
  reviews. They are not posted class-wide. The teacher can read the review in the student reports
  and the student has to go back to their reading log to read the review. There is also a student
  opinion field that is a dropdown with choices.
- Responses to and results of quizzes, surveys and activities (all multiple choice). "Think More" activities capture the percentage and number of questions a student gets correct for each skill. In addition, the number of "Think Mores" taken by a student is also recorded. Students also get LitBits (points) for achieving particular goals like completing the interest survey, completing a book, completing an extra long book, meeting reading goals, exceeding reading goals, getting a 100% or 70-90% on a "Think More", rating and reviewing a book, and reading streaks.
- Literacy assessments including student reading level. Assessments can be manually entered by
  the teacher or determined from taking the Scholastic Reading Readiness (grades K-1) informs
  teachers about their early readers' grasp of foundational skills and their reading ability. The
  results of this optional assessment will help teachers determine a student's ability to

independently navigate *Literacy Pro*. Scholastic Reading Measure (grades 2-6) is an adaptive reading assessment that provides a valid and reliable Lexile® measure to accurately match students to book titles.

- Analytics aggregate, anonymous student usage data such as page visits/views, time spent, number of clicks on elements within the page; not tracked for or tied to individual students.
- School name and location (not collected through the application but part of customer information/class rostering)
- Grade level (as part of class roster)
- Teacher (as part of class roster)
- IP addresses are collected as part of a log file to prevent cyber attacks and to measure aggregate site usage and performance.
- Email addresses of non-student users (teachers, administrators) are stored in Scholastic Digital Manager for individual log-ins.

## EXHIBIT "C"

### **DEFINITIONS**

Contractor: For purposes of the EULA, the term "Contractor" means Contractor of digital educational software or services, including cloud-based services, for the digital storage, management, and retrieval of pupil records. Within the DPA the term "Contractor" includes the term "Third Party Contractor" as used in the Student Data Protection Act and "Operator" as used in COPPA.

**De-Identified Information (DII):** De-Identification refers to the process by which the Contractor removes or obscures any Personally Identifiable Information ("PII") from Education Records in a way that removes or minimizes the risk of disclosure of the identity of the individual and information about them.

Education Records: Educational Records are official records, files and data directly related to a student and maintained by the school or local education agency, including but not limited to, records encompassing all the material kept in the student's cumulative folder, such as general identifying data, records of attendance and of academic work completed, records of achievement, and results of evaluative tests, health data, disciplinary status, test protocols and individualized education programs. For purposes of this DPA, Education Records are referred to as Student Data.

Personally Identifiable Information (PII): The terms "Personally Identifiable Information" or "PII" has the same meaning as that found in U.C.A § 53E-9-301, and includes both direct identifiers (such as a student's or other family member's name, address, student number, or biometric number) and indirect identifiers (such as a student's date of birth, place of birth, or mother's maiden name). Indirect identifiers that constitute PII also include metadata if protected by applicable law or other information that, alone or in combination, is linked or linkable to a specific student that would allow a reasonable person in the school community, who does not have personal knowledge of the relevant circumstances, to identify the student with reasonable certainty. For purposes of this DPA, Personally Identifiable Information shall include the categories of information listed in the definition of Student Data.

Student Generated Content: The term "student-generated content" means materials or content created by a student during and for the purpose of education including, but not limited to, essays, research reports, portfolios, creative writing, music or other audio files, photographs, videos, and account information that enables ongoing ownership of student content.

**R277-487, Public School Data Confidentiality and Disclosure:** The implementing Rule authorized by Utah Constitution Article X, Section 3, which vests general control and supervision over public education in the Board, and further authorities the Board to make rules to establish student data protection standards for public education, pursuant to Subsection 53E-9-302(1) of the Utah Student Data Protection Act.

**EULA**: Refers to the Contractor's End User License Agreement to which this DPA supplements and modifies.

School Official: For the purposes of this Agreement and pursuant to 34 CFR 99.31 (B), a School Official is a contractor that: (1) Performs an institutional service or function for which the agency or institution would otherwise use employees; (2) Is under the direct control of the agency or institution with respect to the use and maintenance of education records; and (3) Is subject to 34 CFR 99.33(a) governing the use and re-disclosure of personally identifiable information from Education Records.

Student Data: Student Data means personally identifiable information, whether gathered by Contractor or provided by LEA or its users, students, or students' parents/guardians, that is descriptive of the student including, but not limited to, information in the student's educational record or email, first and last name, home address, telephone number, email address, or other information allowing online contact, discipline records, videos, test results, special education data, juvenile dependency records, grades, evaluations, criminal records, medical records, health records, social security numbers, biometric information, disabilities, socioeconomic information, food purchases, political affiliations, religious information text messages, documents, student identifies, search activity, photos, voice recordings or geolocation information. Student Data shall constitute Education Records for the purposes of this Agreement, and for the purposes of Utah and federal laws and regulations. Student Data as specified in Exhibit "B" is confirmed to be collected or processed by the Contractor pursuant to the Services. Student Data shall not constitute that information that has been aggregated, anonymized or de-identified, or anonymous usage data regarding a student's use of Contractor's services.

Subscribing LEA: An LEA that was not party to the original Services Agreement and who accepts the Contractor's General Offer of Privacy Terms.

Subprocessor: For the purposes of this Agreement, the term "Subprocessor" (sometimes referred to as the "Subcontractor") means a party other than LEA or Contractor, who Contractor uses for data collection, analytics, storage, or other service to operate and/or improve its software, and who has access to PII.

Targeted Advertising: means presenting advertisements to a student where the advertisement is selected based on information obtained or inferred over time from that student's online behavior, usage of applications, or student data. Targeted advertising does not include advertising to a student (i) at an online location based upon that student's current visit to that location; or (ii) in response to that student's request for information or feedback, without retention of that student's online activities over time for the purpose of targeting subsequent ads
