1. Who We Are

Breezin' Thru Inc. provides two online programs for learning music theory and composition, Breezin' Thru Theory and Breezin' Thru Composing. Breezin' Thru Inc. is committed to protecting your privacy and providing a safe online experience for all. The websites, BreezinThru.com, BreezinThruTheory.com and BreezinThruComposing.com are owned and operated by Breezin' Thru Inc.

2. Breezin' Thru Student Records and Assessment

Breezin' Thru Theory's auto assessed drills are a formative type of assessment. Students are encouraged to try again until they have 100% before they submit results. It's all about drill and practice, and that is the only data we collect. We separately provide printable summative & diagnostic tests for teachers to use and administer to their students, but no data on summative/diagnostic assessment is ever collected or stored by us.

3. Privacy

- a. Breezin' Thru does not collect or store student email addresses, phone numbers, or other personal or sensitive information.
- b. For students 13 and older, if a teacher selects to use the Access ID option, they may also select a setting that allows students to activate and retrieve their ID with an email address. 4. Login Process

- a. All school purchases come directly from the school, teacher or district representative. We do NOT have any contact with students
- b. Teachers and students access Breezin' Thru via our website.
- c. Teachers can choose from two options for logging in: SSO with Google Classroom, or Breezin' Thru's regular login system.
- d. For the regular method of logging into Breezin' Thru:
 - i. We create and provide teachers with 2 login accounts. One that is used by the teacher(s) and another one that is universal and used by all students.
 - ii. Teachers set up "course names" so that when students go to login into Breezin' Thru, they enter the universal "Breezin' Thru" student login, and choose a class name which has been set up by the teacher.
 - iii. If the district policy does not want student names to be used, teachers can select the setting that directs students to have an Access ID created.
 - iv. Student Access IDs are set up the first time students log in and do not require an email address. They can be retrieved if forgotten, from the teacher.
