<p>CONTRACT DURATION AND DATA DESTRUCTION INFORMATION</p>	<p>The agreement expires June 30, 2022 with an automatic renewal, unless either party gives notice to terminate.</p> <p>Upon expiration of this Contract without a successor agreement in place, Frontline will delete all protected data previously received from BOCES or a Participating School District upon request, unless alternative arrangements are made with Frontline to continue using Frontline Services. Frontline shall provide commercially reasonable support to BOCES to extract data from Frontline Services in a format suitable for transfer to another service or platform..</p>

DATA ACCURACY INFORMATION
