
**Data Transition
and Secure
Destruction**

Upon expiration of the Agreement to which this Agreement applies, without a successor agreement in place, Contractor shall assist CUFSD in exporting all student, teacher and/or principal data previously received by Contractor from, or developed on behalf of, CUFSD, and Contractor shall, at the request of CUFSD, either securely delete any student, teacher and/or principal data which containing PII remaining in Contractor's possession or return the student, teacher and/or principal data to CUFSD. If student, teacher and/or principal data is to be maintained by Contractor for any lawful purpose, such data shall remain in an encrypted format and shall be stored on systems maintained by Contractor in a secure data facility.

**Challenges to
Data Accuracy**

Parents, teachers or principals who seek to challenge the accuracy of PII will do so by contacting CUFSD. If a correction to data is requested, they will comply with CUFSD policies. If an inquiry is found to be warranted, CUFSD will contact Contractor who will assist CUFSD with the inquiry.
