

## **AGREEMENT TO EXTEND DATA SECURITY AND PRIVACY PLAN**

**WHEREAS**, Agile Sports Technologies, Inc. dba Hudl, having offices at 600 P Street, Suite 400, Lincoln, NE 68508 (hereinafter the “Contractor”) and Southern Westchester Board of Cooperative Educational Services, having offices at 17 Berkley Drive, Rye Brook, New York 10573 (“Southern Westchester BOCES”) agreed upon a Data Security and Privacy Plan that was signed on behalf of Contractor on Nov 21 2024, and signed on behalf of Southern Westchester BOCES on Nov 21 2024 (hereinafter the “Plan”); and

**NOW, IT IS HEREBY AGREED AND STIPULATED** by and between the Contractor and Southern Westchester BOCES, for good and value consideration the exchange of which is acknowledged by the parties, that:

1. The Plan is re-adopted and extended for the period July 1, 20<sup>25</sup> through June 30, 20<sup>26</sup> (the 20<sup>25</sup> -20<sup>26</sup> school year) with all terms and conditions therein remaining in full force and effect, except to the extent specifically modified herein. The parties agree that as of the date the Plan went into effect (November 21, 2024), the reference in the introductory paragraph in the Plan to “the Master Agreement, dated November 13, 2024, whose term commences on July 1, 2024 (hereinafter the “Agreement”)” is hereby updated to the following: “the Master Agreement, dated December 12, 2024, whose term commences on July 1, 2024 (hereinafter the “Agreement”)”.

2. As provided in Paragraph “9” of the Plan and Paragraph “(3)” of the Supplemental Information component of Schedule B-1 to the Plan, upon the termination or expiration of the Master Agreement, all student data or teacher or principal data remaining in Contractor’s possession will be returned to Southern Westchester BOCES and/or the Purchasing Schools/BOCES upon request within sixty (60) days of such request.

3. The Plan shall be deemed to be a part of the renewed Agreement(s) for services between the Contractor and the Southern Westchester BOCES applicable during the 20<sup>25</sup> - 20<sup>26</sup> school year.

4. In connection with the execution of this Agreement to Extend Data Security and Privacy Plan, Southern Westchester BOCES and the Contractor agree that digital signatures generated through electronic signatures shall have the same force and effect as original signatures.
